## Fiat Chrysler launches Made-in-India Jeep Compass at Rs 14.95 lakh

**New Delhi,** Fiat Chrysler Automobiles (FCA) India on Monday announced the launch of its Made-in-India Jeep Compass. The vehicle's petrol powered version comes at a starting price of Rs 14.95 lakh (ex-Delhi), while the diesel fuelled variant has a starting price of Rs 15.45 lakh. The company said deliveries of the sports utility vehicle (SUV), which is available for test drive and bookings at the 50 FCA and Jeep retail outlets across India, will begin nationwide on August 6, 2017. According to the company, the SUV will be available with 2-litre multijet turbo-diesel and 1.4-litre multi-air petrol engines. "Packed with 50+ safety and security features, 30+ premium features and 20+ pioneering technologies, the Jeep Compass is manufactured in FCA's Joint Venture manufacturing facility in Ranjangaon, near Pune, and is made of 65 per cent locally sourced components," the company said in a statement.

## Maruti Suzuki's July sales up over 20%

**New Delhi,** Automobile major Maruti Suzuki India on Tuesday reported a rise of 20.6 per cent in its monthly sales for July 2017. According to the company, its total sales during the month rose to 165,346 units from 137,116 units sold during the corresponding month of 2016. Maruti's domestic sales edged higher by 22.4 per cent to 154,001 units from 125,778 units. However, exports inched-up by 0.1 per cent with only 11,345 units shipped out during July 2017, down from 11,338 units sold abroad in the like period of 2016. Segment-wise, sales of passenger cars was higher by 19.4 per cent to 111,803 units against 93,634 units during July 2016. The company's passenger car segment comprises of brands like Alto, WagonR, Swift, Ritz, Celerio, Ignis, Baleno, Dzire, Dzire Tour (old), and Ciaz. Besides, sales of Maruti's utility vehicles -- brands like Gypsy, Ertiga, S-Cross and Vitara Brezza -- exponentially increased by 48.3 per cent to 25,781 units. The off-take in the van segment, which includes brands like Omni and Eco, increased by 6.6 per cent to 15,714 units.

## Media credibility at 50-55 per cent, slipping, says Parrikar

**Panaji,** Goa Chief Minister Manohar Parrikar on Tuesday said the Indian media's credibility is presently at 50-55 per cent and slipping. He stressed the need for credibility of news. During his earlier stint as the Chief Minister in 2002, news credibility was around 75 per cent, which had since slipped to 50 to 55 per cent, Parrikar said at a function organised here by the Goa Journalists Union on the death anniversary of freedom fighter Lokmanya Bal Gangadhar Tilak. Parrikar said the figures were based on the veracity of news reports in 2002 and present times, gauged by government inquiries initiated after news stories pointed out lacunae and mismanagement. He stressed the need to guard the credibility of news reports. "The government should be criticised. I always say that a critic's home should be in your neighbourhood. Newspapers are useful to me because we then know what is happening around us. A Chief Minister cannot know what a 60,000 workforce is doing," Parrikar added. He said his penchant for getting into arguments with journalists doesn't mean he is pressurising them. "The Press is our eyes and ears. However, much as I fight, there is no malice. It is to correct. I say what I feel. Some people say the Chief Minister is trying to pressurise. Don't get pressurised if I argue with you. The argument is to put across my viewpoint," the Chief Minister said.
