Scammers often misuse trusted brand names to appear legitimate, tricking job seekers into paying upfront fees for training, visa processing, background checks, or even simple application submissions and interviews. Government actions against overseas fake recruitment networks, including the rescue of exploited Indian workers, demonstrate the tangible risks these scams pose and the urgent need for vigilance.

How to Spot Fake Job Offers

- * Promises of high earnings for simple or part-time work, including "captcha-filling" tasks.
- * Requests for urgent payments related to job applications, training, overseas placement interview opportunities or job confirmations.
- * Unsolicited calls, emails, or WhatsApp messages claiming to be HR from reputed organizations asking for personal or financial information. Referral schemes offering extra income for recruiting others.
- * Fake websites or email addresses mimicking official company domains, such as fedx.com or fed-ex.com. Communications with poor spelling, grammatical errors, or excessive capitalization and exclamation points.
